## Celebrating successful advocacy

In my last letter, I mentioned the financial pressures we have experienced related to increased personnel expenses. Thanks to efforts by our board members, executive staff, and advocates like you, we received additional support from the Kentucky legislature in the Commonwealth's new 2-year budget. It was especially gratifying that members from both sides of the aisle and from across the Commonwealth understood the importance of our services. We recognized several legislators at our recent luncheon and presented The Butterfly Effect award to Senator Julie Raque Adams for her role in championing these efforts on behalf of Maryhurst.

Maryhurst's primary advocacy focus will now shift to increasing funding for our community-based counseling services that aim to keep families intact and reduce the need for residential treatment. Maryhurst remains committed to early intervention, and we are excited to continue working with our partners at the local, state, and federal levels to ensure adequate funding is available to sustain our life-changing services.

## Celebrating a successful accreditation visit

Maryhurst received news this month that we have again been approved by the national Council on Accreditation. The accreditation process occurs every four years but takes more than a year to prepare for.

#### Planned Gifts

Making a planned gift isn't hard, but it takes . . . well, planning! A 2021 Gallup poll found that less than half (46%) of US adults say they have a valid will. Without a will, the government will decide how your assets are distributed. With a will, you can be sure your family is taken care of in the way you think is best. You can also consider the causes and organizations that were important to you during your life (e.g., your faith community, alma mater, and charities of choice).

For example, an endowed gift of \$20,000 in your estate would provide approximately \$1,000 per year to Maryhurst forever.
